19 Course Description:

This course focuses on the political and legal framework that shapes healthcare management, services and delivery. The course touches upon the role of government agencies in health regulation and the legal aspects of disease control and prevention, access to care and justice. Students will learn how to interpret current controversies around health policy and develop informed opinions on potential future policy developments. Additionally, the course explores ethical considerations and challenges in balancing individual rights with the collective well-being of communities.



20 Course aims and outcomes:

A- Aims:

This course aims to introduce key explanatory theories of health policy and law. The course includes discussion and debate of real-world examples and case studies. It is designed to equip students to study and work in the health policy and law arena at international, regional, and national levels by providing them with tools to understand and act in the health policy field.

B- Students Learning Outcomes (SLOs):

Upon successful completion of this course, students will be able to:

1. Review the various fundamental theoretical stances and ideas that are employed in health policy analysis;
2. Examine the political framework that guides policymaking as well as the external variables that affect policy shifts;
3. Determine who the critical players are in the formulation of these policies and comprehend some of the control and sway over changes to policy;
4. List the essential components of the processes for identifying, formulating, and executing;
5. Make a plan for utilising the policy analysis framework in the research module and making choices.
